INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The NATIONAL POWER CORPORATION, SMALL POWER UTILITIES GROUP-LUZON OPERATIONS DEPARTMENT (SPUG-LOD), through its Bids and Awards Committee (BAC), invites contractors registered with and classified by the Philippine Contractors Accreditation Board (PCAB) to apply for eligibility and if found eligible, to bid for the hereunder contract:

Prospective bidders should possess a valid PCAB License (Small B Category C & D) applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility Forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R. A. 9184 and its Implementing Rules and Regulation (IRR).

Interested Bidder must submit a Letter of Intent to apply for eligibility and to bid in order to be issued with Eligibility Documents upon payment of a non-refundable amount of One Thousand Pesos (Php 1,000.00) to the Cashier. The Eligibility requirements must be delivered to the address given below to the BAC Secretariat.

A complete set of bidding documents shall be made available to eligible Bidders only upon payment of a non-refundable amount of Three Thousand Pesos (Php 3,000.00) to the Cashier. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. All bids must be accompanied by a Bid Security in the form as stated in the Tender Documents. Late bids shall not be accepted.

The SPUG-LOD reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
