2. NPC now invites Bids for GOODS/SERVICES listed above. Delivery of the GOODS/SERVICES is required by the date indicated in the bid documents. Bidders should have completed, within the prescribed period indicated in the bid documents from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Revised Implementing Rules and Regulations of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A. 5183) and subject to Commonwealth Act 138 (C.A. 138).
4. A complete set of Bidding Documents may be secured by interested Bidders on **Sept 1, 2011** from 9:30 P.M. to 4:30 P.M. Monday to Friday from the address stated below. It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of NPC stated below.
5. Bids must be delivered to the venue specified above on or before the dates stated above. All Bids must be accompanied by a Bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
6. NPC reserves the right to accept or reject any Bid, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected Bidder or Bidders.
