



INVITATION TO APPLY FOR ELIGIBILITY AND TO BID

The SMALL POWER UTILITIES GROUP –MINDANAO OPERATIONS DEPARTMENT (SPUG-MOD), through the NATIONAL POWER CORPORATION (NPC) Corporate Budget for CY 2011 intends to apply the Approved Budget of the Contract (ABC) to payments under the contract:

Brief description:	To Supply Labor, Materials, Tools and Equipment for the Rehabilitation of Catwalk and Off-shore Perimeter area at Power Barge 108 (PB 108)
Approved Budget for the Contract (ABC):	Php 2,796,478.00
Contract Duration:	One Hundred Twenty (120) calendar days

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The NPC SPUG-MOD now invites bidders for the aforementioned projects. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

- a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **National Power Corporation SPUG-MOD** and inspect the Bidding Documents at the address given below from **9:00AM – 4:00PM Monday to Friday**.

A complete set of Bidding Documents may be purchased by interested Bidders on June 21, 2011 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Four Thousand Pesos (Php 4,000.00)**.

It may also be downloaded free of charge from the website of the Procuring Entity (www.napocor.gov.ph, www.philgeps.net and www.spug.ph), provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The **NPC SPUG-MOD** will hold a Pre-Bid Conference as stated in BAC activities which shall be open only to all interested parties who have purchased the Bidding Documents.

Bids must be delivered to the address below as stated in BAC activities. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


